

BYLAW NO. 4-2018


A BYLAW FOR THE HAMLET OF ST. VICTOR IN THE RURAL MUNICIPALITY OF WILLOW BUNCH NO. 42 TO ESTABLISH THE RATES TO BE CHARGED FOR THE SUPPLY AND CONSUMPTION OF WATER AND THE USE OF SEWER AND DISPOSAL SYSTEM

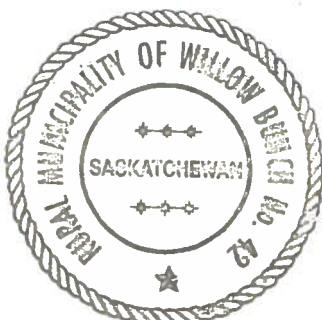
COUNCIL of the Rural Municipality in the Province of Saskatchewan, enacts as follows:

1. The charges to be paid by the water consumer whose water service has been turned on shall be those set out in Schedule "A" attached; provided, however, that the minimum shall be payable in every case whether or not any water is consumed.
2. Persons who own or occupy premises drained or that are by bylaw required to be drained into the sewer shall pay for such services a rental rate or service charge in accordance with Schedule "B" attached.
3. Accounts for water service and/or sewer service shall cover a period of three successive months, and shall be billed on or before the first day of the month next following such period. Accounts shall be paid by the 31st of the 3rd month of each period. If an account is not paid, the water service may be cut off. When the water service is cut off, it shall not be turned on until all arrears have been paid, together with a fee of **\$40.00 dollars** to cover the expenses of turning off the water and turning it on again; provided that if it is required to turn on the water service outside the employees' regular working hours, the fee shall be **\$ 50.00 dollars**.
4. A penalty of \$10.00 per month shall be charged on all water and sewer rates unpaid by their due date.
5. All users of the public utility system shall pay a utility infrastructure fee of \$10.00/month that is designated to be used for future capital water and sewer infrastructure projects.
7. The RM shall have the right to ration or limit the amount of water furnished to any or all consumers, should circumstances seem to warrant such action.
8. All utility rates hereby established or established by resolution of the RM Council under the provisions hereof are hereby constituted as a lien on real property and may be levied and collected in the same manner as taxes from the owner if not paid by a tenant or occupant.
9. Bylaw No. 1-2005 is hereby repealed.


THE rates, charges, tolls or rents contained in this bylaw shall come into force on January 1st, 2019 and take effect on that day and upon approval by the Municipal Board.
